Pension Files For William Sanders Give Researcher Some Valuable Information

Bonnie Andersen has recently found some significant information about her ancestor, William Sanders of Kingsessing, Pa. This is an example of some of the better information that can be obtaining from Revolutionary War pension files. Here is what she transcribed from some of the handwritten files:

Declaration in Order to obtain benefits of the Act of Congress, passed June 7th, 1832.

State of Ohio Columbiana County

On this twenty-ninth day of April 1833 personally appeared in open court before the Court of Common Pleas, now sitting William Sanders resident of the said county of Columbiana and state of Ohio, aged eighty-seven years the thirty-first day of May next, who being first duly sworn according to law, doth, in his oath, make the following declaration, in order to obtain the benefits of the act of congress passed June 7th. 1832: that he entered the service of the United States under the following named officers, and served as therein stated, that he was drafted in Philadelphia county vicinity Pennsylvania in a company commanded by Captain Isaac Warner, in a regiment commanded by Colonel Pascal, the day, month or year he cannot recollect, that he marched from Philadelphia to New York and remained there for two months when the time for which he was drafted expired; that he was afterwards drafted in Philadelphia county, and marched in a company commanded by Captain Roberts to Newton in Bucks county, Pennsylvania, and remained there about two months when the time for which he was drafted expired and returned to his home near Philadelphia; that he was again drafted near Philadelphia and marched in a company commanded by Captain John Young up the Delaware river and camped at Connelly's Ferry into New Jersey in

pursuit of the British who were destroying the property of the inhabitants; that he served on this tour two months for which he was drafted and returned home as last mentioned; he drove a team with a baggage waggon up above Germantown and was there taking care of the baggage at the time of the battle, that some time after the battle he returned home having been out two months on this tour, that sometime after he returned home as last mentioned he again drove a team with a baggage waggon up the Schuylkill to Valley Forge near which was the American Army on one side and the British on the other where he remained until the expiration of the two months for which he was engaged and then returned home. He further states that he served another tour of two months in driving baggage waggon to the head of ?? the time the army marched there, and he then returned home. He further states that he took two prisoners, marched them to headquarters, but this was not during any of his tour of duty; that he has no documentary evidence to prove his service. He hereby relinquishes every claim whatever to a pension or annuity in up to the present, and declares that his name is not on the pension roll of the agency of any state. Sworn to and subscribed, the day and year aforesaid.

Mr. Jacob Sanders & Abraham Robins residing in the said county of Columbiana, hereby notify, that we are well acquainted with William Sanders, who has subscribed and sworn to the above declaration, that we believe him to be eighty-seven years of age, that he is respected and believed in the neighborhood where he resides to have been a soldier of the revolution, and that we

Mario Perrino's "Brick Wall" is Elijah Sanders, Born About 1797 in Cumberland Gap, Ky.

From Mario Perrino, 2941 Country Woods Lane, Cincinnati, OH 45248 5058, <mperrino@cinci.rr.com>. My brick wall is Elijah B. Sanders. I cannot find out who his ancestors were. Here's the information I have concerning Elijah B. He was born about 1797 in Kentucky while his family was apparently traveling through the Cumberland Gap from the Carolinas. He had a brother named Reubin P. Sanders who was born about 1794 in South Carolina. I have been told that Elijah's father may have been George W. Sanders and he had additional siblings named Elihu and possibly John, William, and Elisha.

There are a number of land transactions in White and Warren Counties, Tenn. between 1810 and 1820 that list the names of George, Elijah, Elijah B., Reubin P., George W., and Elihu Sanders/ Saunders. Land records showed Elijah B. purchased and sold land in White Co., Tenn. between 1809 and 1820, and he was living in Ala. between 1816 and 1829. Following are a few of them.

From Warren Co., Tenn. Deed Book A, page 511-512 20 June 1816. Elijah B. Sanders, George W. Sanders, Elijah Sanders Sr., Elisha Sanders of White and Warren Co. to Randolph Ross of Virginia for \$100.00, - 60 acres in Warren Co. including the pond near the Arch Cave which is part of one moiety (a half) of one tract of 30 acres granted to Elijah Sanders and Elijah Drake by Grant #5137 which now remains unconveyed, the residue thereof having heretofore been conveyed to a certain Tucker M. Woodson bounded by Thos. S. Williams line, Reuben P. Sanders corner, corner of George W. Sanders' 970 acres. Reg. 21 April 1818.

From Warren Co, Tenn. Deed Book A, page 513-14 18 Oct 1817. Elijah B. Sanders, to George W. Sanders both of White Co., Tenn. for \$100.00, the following tracts of land - 30 acres granted by the state of Tennessee by Grant #5137 to said Elijah B. Sanders and Elijah Drake.. John S. Williams corner.. Reuben P. Sanders corner. The other containing 970 acres granted by the state of Tennessee to Elijah B. Sanders and Elijah Drake by Grant #5142. Reuben P. Sanders corner.. including Big Bone Cave.. the mouth of Arch Cave. Reg. 24 April 1818.

From Warren Co., Tenn. deed book

D, April 1820 January 1824, page 186 has this entry - 8 August 1821: Elijah B. Sanders of Madison Co., Alabama to Michael Dean of Warren Co., Tennessee, 13 acres granted to Elijah B. Sanders by the state of Tennessee, Grant #12660 dated 27 October 1818. Signed Elijah B. Sanders by his attorney in fact, George W. Sanders. Witnesses: M. Hogan, J. T. Jones 15 October 1821, proven by oath of Marcus Hogan and J. T. Jones. Registered 17 October 1821.

Reubin, George and Elijah moved to Madison Co., Ala. sometime around 1822-23 and then moved to Lowndes Co., Miss. near present day, Steens, northeast of Columbus, Miss. About 1828, Elijah B. and Reubin P. were lay preachers and charter members of a group that organized the first Methodist Church in Lowndes Co. known as Piney Grove Methodist church.

Elijah B. was listed in the 1830 Lowndes Co., Miss. census. I also found him in the 1840 Lowndes Co., Miss. census, in the 1850 Pontotoc Co., Miss. census, in the 1860 Pontotoc Co., Miss. census and in the 1870 Chickasaw Co., Miss. census. I have been unable to locate later information about Elijah B. after the 1870 census. Elijah B. and Lydia's children were Jesse, b. abt 1816; William, b. abt 1821; Martha, b. abt 1824; Elijah Simpson, b. abt 1825 (all born in Alabama); Lydia C., b. abt 1829; Martin S., b. 12 Nov 1830; Elizabeth, b. abt 1834; Sarah J., b. abt 1835; Arminda, b. abt 1837; and Elzy W., b. abt 1842 (all born in Miss.).

Presley Sanders' Parents Finally Located

Presley Sanders' parents were Almond Sanders and Patsy (Martha) Dye. Martha's parents were Fauntleroy Dye and Annie Kelley. They were in Richmond County, Va. I also have Fauntleroy Dye's family back another three generations. Fauntleroy Dye was in the Navy in the Rev. War and I have sent for his military papers but have not received them yet.

Milton Saunders, Deaf From Measles Illness, Led Successful Life

MILTON SAUNDERS was born October 3, 1836 in Springfield, Illinois, to Jonathon Robinson and Sarah [McKinnie] Saunders. Some family bible records of Jonathon shows Milton as James. His father, Jonathon R. Saunders, was born February 17, 1802 in Fleming Co., Ky. to Gunnels and Mary [Mauzy] Saunders. Sarah McKinnie was born to Lewis and Nancy [Saunders-Gunnell's sister] McKinnie in Fleming County on January 16, 1801. Milton grew up outside Springfield and received a common school education. He learned farming from his father, Jonathon. He married January 1, 1861 to Anna E. Edwards, who preceded him in death at the age of 23 years in or about 1863. They had three daughters: Nellie Etta, Cora, and Frances Sarah/Sarah Frances. Not sure if Frances was Anna's daughter or Martha's or if date is right. In 1868, their daughter Cora died. Milton became ill with measles, as a result he lost his hearing. School record shows he was admitted in 1849. So his father sent him to nearby Jacksonville, Morgan County, Ill., where the Jacksonville Institute for the Deaf is located. The school records show his marriage to Anna E. Edwards as a speaking lady of mute parents. He attended school there, and met a former student and matron of the school, Martha E. Beeley. School records record that Martha was born deaf and placed in the school by her mother. The two married August 28, 1872 in Morgan County, and moved back to Springfield, starting a farm twelve miles north of Springfield on Peoria Road, at a place known as Twelve Mile Place where a Public Inn used to be located. They had three children: Lillian, Marcia D., and only son Milton, Jr. School records say that he prospered and that all their children could hear. He was known as a good farmer and stockman. He retired from farming 1892 and moved in to Spring-field. He passed away at age 66 years, October 18, 1902 in Springfield, Ill. Both Milton and second wife were deaf. ■

Interrogations propounded by the court

- 1. When and in what year were you born? Answer: In Kingsessing near Philadelphia, Penna and the year 1746.
- 2. Have you any record of your age and if so where is it? Answer: I have not except my indenture of apprentice, which is at my house where I live.
- 3. Where were you living when called into service; where have you lived since the revolutionary war and where do you live now? Answer: Near Philadelphia, Penna where he remained until two years since when he removed to the county of Columbiana, Ohio.
- 4. How were you called into service; were you drafted; did you volunteer, or were you a substitute? Answer: I was drafted.
- 5. State the name of some of the regular officers who were with you, the troops where you served, such continental and militia regiments you can recollect, and the general circumstances of your service. Answer: It is a long time since and I cannot distinctly recollect any others than those I have named, Colonel John Pascal, Captains Warner, Roberts, and Young.
- Did you ever receive any discharge, I did not receive any written discharges.

Name any persons in your neighborhood that can testify to your character and services as a revolutionary soldier. Answer: Jacob Sanders and

Congressman "Howdy" Martin of Texas Had Some Sanders Descendants

William Harrison Martin was born September 2, 1822 in Twiggs County, Georgia. He moved to Henderson County, Texas in 1851 and began to practice law. Later, he was a state Senator, a member of Hood's Brigade during the Civil War, and a U.S. Congressman. He was called "Howdy Martin" in tribute to his invariable greeting to everyone he met. He moved to Hill County in 1894 and died there in 1898.

From Family Histories of Henderson County, Volume 1, 1981, Henderson County Historical Commission, p. 216: "One of Howdy Martin's daughters, Martha Sanders, returned to Athens as a widow with three children. A grandson, Robert Sanders, became a prominent citizen of Athens, residing there until his death in 1961. A historical marker has been erected to the memory of Howdy Martin with granddaughter Ruby Lee Sanders Schiwetz present."

Martha Elizabeth Martin, born 17 Dec 1878 Athens, Henderson County, Texas; married John Bunyan Sanders circa 1897 Walnut Springs, Bosque County, Texas; died 4 Apr 1963 Athens, Henderson Co., Texas, at age 84; buried after 4 Apr 1963 Old Cemetery, Hillsboro, Hill County, Texas. Children of Martha Elizabeth Martin and John Bunyan Sanders were as follows:

i. Robert B. Sanders, born 1898 Walnut Springs, Bosque County, Texas; married Frances Marie Dunn. Robert B. Ruby Lee was a artist whose paintings and sculpture won prizes. Some of her works in ceramics are among the permanent collection of the Dallas Museum of Fine Art.

iii. Hugh Sanders; born after 1902 Athens, Henderson County, Texas.

Saunders-Monticello Trail Has Bridge Named Saunders

CHARLOTTESVILLE, Va. - Saunders Bridge, the new entrance to Thomas Jefferson's Monticello, was opened to traffic at 3 p.m. today (Wed., July 3).

Saunders Bridge is a stone-arch span over Route 53 with a cloverleaf roadway that allows vehicles traveling eastbound on Route 53 to enter Monticello without turning left across lanes of oncoming traffic. The bridge is the capstone of the Thomas Jefferson Parkway, a linear park along Route 53 that includes Kemper Park and the Saunders-Monticello Trail. A walkway on the bridge will be connected to the Saunders-Monticello Trail later this summer, which will allow pedestrians and cyclists to enter the grounds of Monticello from the trail.

Work on the \$3.4 million bridge project began in July 2000, with W.C. English, Inc., of Lynchburg the general contractor and Peter Hatch, Monticello's director of gardens and grounds, the project manager.

Saunders Bridge was named in recognition of a leadership gift from Thomas A. Saunders III, chairman of the Thomas Jefferson Foundation's Board of Trustees, and his wife, Jordan. Thomas Jefferson himself envisioned constructing a bridge at this same location, called Thoroughfare Gap, to connect Monticello with Montalto, now known as Brown's Mountain.

Although Jefferson never constructed a bridge at the site, he was an admirer of stone-arch bridges. In 1787, he described the new stone-arch Pont du Neuilly in Paris as "the handsomest bridge in the world."

Joseph Sanders/Mary Lamb Are Brick Walls For Kerry Sanders in Iowa

Kerry A. Sanders, 3900 Beverly Road, SW, Cedar Rapids, IA 52404. "My Wall," if you will, has been from Joseph Sanders/Mary Lamb and earlier. My father had information passed down to him from my grandfather, starting here, indicating one of his sons, Henry (b. 26 Oct 1751 and marrying Dica Blake) went forward to sire a Joseph who married Nancy Cox. They had 12 children, of them, Levi is my direct ancestor. From Levi, there was Wright, then Edward Barton Sanders, then Lloyd, then my father John Sanders (b. 23 Sep 1929). It noted this Joseph was the grandson of the Joseph that came from England. As I searched the internet sites, most noted that Joseph's father was Benjamin, whose father was William (Mary Hall), whose father was a John Sanders (b. 1611 or 1613 in England). There in a nut shell is my "wall." Very little confirmation of anything. I have exchanged e-mails with Gary who pretty much confirmed that.... very little confirmation. Do you have anything or any sources I can check? During 1634-1656 there were five Johns coming from England, and one William... a woman who provided information to the LDS web, noted John coming on the Merchant's Hope, born in 1611, marrying Susannah Ravenett..... The Merchant's Hope noted John to be 22, coming in 1635.... (Therefore born in 1613). I would appreciate any light you could shed.... I have a friend in England who is going to try and check some things for me at some point and I have received some good early information from some sources in England.

Old Newspaper Yields Interesting Information About Lost Town of Saundersville, Illinois

(This article on Saundersville was submitted by Susan Saunders, 4462 E. 1251 Rd. TrIr. 9, Earlville, IL 60518, <susansaunders@msn.com>.) This a copy of a newspaper article I received from my third cousin, Don Gibbs of Springfield, Ill. There is no date but an article under it states the "marriage" was dissolved 1908. So this is some time after January 1908. I am looking for any info on Saundersville.

"Land is in Northeast part of Springfield and Proposition to come in almost unanimous—No election is required, but requires more work for Commission—Condemnation Suit of City is Called in County Court—information filed against Saloonkeepers.

"Saundersville is now a part of the city of Springfield. An order approving the annexation was acted upon yesterday afternoon by Judge James A. Creighton in the circuit court and the new territory comes under the reign of the local municipal officials. The peti-

tion was presented to the city council several weeks ago, and bore the signatures of a majority of the residents of the territory. The district lies north and east of Sangamon avenue and extends from Eleventh street to the Chicago, Peoria & St. Louis Road. It has a population of 1,000 persons. When the former village of Ridley was annexed, residents of Saundersville practically were alone and they asked admission. The necessary legal steps were taken and papers were made matters of record. Under the law, the territory can be annexed by petition and the voters of Springfield will not be called upon to approve or disapprove the

"The annexation throws additional work on the election commission. The district adjoins the north precinct of the first ward, and it is probable a new precinct will be declared or new boundary lines will be so changed as to allow the voters to cast ballots at the coming spring election."
