Early Montgomery County, N.C. Sanders Detailed In Research By Jim Sanders, Part 2

To continue what was published in the last issue of *Sanders Siftings* (part 1) from Jim Sanders' booklet, *The Sanders Families of Montgomery County, North Carolina*, 1757-1810, I have below Part 2, that is on pages 5-11. This is based primarily on land records that Jim has researched. Copies of many of the land records are included in the booklet.

Aron Sanders 1785

We believe that the Aron Sanders, noted as a chain carrier, on the grant to Elias Butler in April 1785, was Moses Sanders' son. When properties adjacent to William Aaron Sanders were to be sold, subsequent to his death, Joanah, who was Aaron's wife and living on the property, would have summoned her "Justice of the Peace" brother-in-law, Moses, to ensure that the passing of title, would not jeopardize her holdings. In 1785 Moses would have been the family patriarch. He is the most closely associated brother to William Aaron. They received their original land grants in 1773 and the land was surveyed on the same day, June 27, 1772. In 1774 they were ordered to build a road together (along with others). In 1775, Moses was a Justice of the Peace and Aaron was appointed as a Constable in

We considered that Aron was Moses' son when his name appeared as a chain carrier in 1785. Then we discovered that Moses moved to Wilkes County in 1782. At 13, Aron would have moved with his father. He then moved to Rowan in 1785. We thought how could he be in two places at once. A possible explanation would be that Aron returned with his father upon notification that the property was being transferred. Aron, returned from Rowan to assist with the survey for Elias Butler.

Aron would have been 16. The second chain carrier on the Elias Butler survey was Stephen Sanders. We believe a cousin.

In 1790, Aron (now spelled "Aaron") was newly married and listed in the census of Montgomery County. There were no children listed. He was in Franklin County, Ga. in 1800 as evidenced by the 1800 tax list. His line has been well researched and documented by Eldon Hurst. Aron is a second generation Sanders.

William Aaron Sanders 1772

William Aaron Sanders' family has been documented by the work of Gary Sanders and others. We have recently discovered that Moses Sanders' brother Aaron and Thomas Bailey Sanders' "William Aaron" Sanders, were one and the same. Our conclusion is supported and based on a couple of discoveries. One was that Aaron Sanders was issued a land grant on May 24, 1773. It was described as "...on the Reedy Fork on Barnes Creek." We've reviewed the original grant. . Nimrod Sanders, William Aaron's son, in 1836, sold this same tract of land to William Strider. The legal descriptions of both transactions are the same. Another important discovery was survey tie-ins'. On two different surveys the same corner "tie-in" is referenced. In the 1785 Elias Butler Survey, the "Widow Sanders" line is noted and is the same bearing and distance on Barnes Creek as in a survey for John Crump in 1794. Aaron's wife would have been known as the "Widow Sanders." Aaron Sanders was killed during the war in 1781, some say by Tories. His estate was administered in Montgomery County in 1782. We have not viewed that record. Of the first generation Sanders, Moses and William Aaron are the most frequently mentioned in the records. In 1774 they (also George and William Hamilton)

Don't Expect Your Computer To Do All; Utilize More Tools

Robert Tilman, CEO of RootsWeb, has said, "Only a small fraction of genealogy-related information is on the Web."

Computers have done a fantastic job of making more genealogy material available to researchers and connecting even more people than we would have ever thought possible. RootsWeb is probably the best place on the Web to get help, or receive help. The past few years I heard from individuals who were related to me on two different lines for which I had nearly given up hope. They saw my posting on the RootsWeb Surname list that has been there for more than nine years.

However, you can't just sit at that computer and expect to do all your genealogy work. I am afraid that we are getting away from some of the traditional tasks related to sound family research. Subscribers to surname newsletters are also declining. Newsletters are still a very good place to find other researchers and information not available elsewhere. You need to get out to those libraries, court houses, cemeteries, and Family History Centers. You still need to write letters to many relatives and friends who may have information you need.

Use all the tools you can. The computer is a great one! And it is one of the best tools that you can have to help write those letters.

In our busy, busy world we all want shortcuts and time savers. Don't shortcut your family research by looking for the easy way out. Keep up the traditional research.

Ensign Eugene T. Sanders, On U.S.S. Arizona, Has Two Navy Ships Named In His Memory

One Sanders lies entombed aboard the U.S.S. Arizona, Ensign Eugene T. Sanders. According to Navy records Eugene Thomas Sanders was born March 15, 1899 in Hubbard, Oregon, the son of William Eugene and Jessie Hinkle Sanders. Other records list Ens. Sanders' birth date as March 15, 1901. The earlier birth date makes sense due to Sanders enlisting in the U.S. Army on June 16, 1917. An 1899 birthday made him eligible for the army, whereas a 1901 birthday would have prevented his enlistment until March 15, 1919.

Eugene Sanders was discharged from the army on February 13, 1919. On September 18, 1919 he enlisted in the U.S. Navy. The 1920 census lists Sanders as a Seaman 2nd Class on the battleship U.S.S. Vermont (BB-20). The latest he could have been on the U.S.S. Vermont was 1924, the year the ship was scrapped.

The 1930 census has 1st Class Signalman Eugene T. Sanders residing at 3685 45th Street in San Diego, Calif. His birth year is listed as 1901. Sanders had been married to Pearl L. Sanders for 2 years. They had no children.

Navy records list Sanders as serving on the mine sweeper U.S.S. Brant (AM-24) from December 4, 1932 to June 1, 1934; the mine sweeper U.S.S. Finch (AM-9) August 30, 1934 to January 28, 1936; the naval station at Olongapo, Luzon, Philippine Islands, January 29, 1936 to April 3, 1937 and the submarine tender U.S.S. Canopus (AS-9), April 6, 1937 to March 10, 1938.

On May 7, 1940 Chief Boatswain Sanders reported to the battleship U.S.S. Arizona (BB-39). Eugene T. Sanders was appointed Ensign on November 3, 1941. One month and four days later he died in the U.S.S. Arizona during the Japanese attack on Pearl Harbor. Ensign Eugene Thomas Sanders' name is found on the U.S.S. Arizona memorial.

Two ships were named for Eugene T.

Sanders. The destroyer escort U.S.S. Sanders (DE-273) was named on February 23 1943, laid down on April 23, 1943 by the Boston Navy Yard, Boston, MA; launched on June 4, 1943; sponsored by Mrs. Eugene Thomas "Sally" Sanders; and leased to Britain on September 30, 1943. Renamed the HMS Grindall (K-477) by Britain, she was returned to the United States on August 20, 1945 and was scrapped on May 28, 1946.

The second ship named Sanders was laid down on September 7, 1942 by the Puget Sound Navy Yard, Bremerton, Wash.; named Sanders on June 14, 1943; reclassified destroyer escort (DE-40) on June 16, 1943; launched on June 18, 1943; commissioned on October 1, 1943, Lt. Comdr. Arthur N. Daniels in command.

After a shakedown cruise, the U.S.S. Sanders participated in patrol and escort duties in the Gilbert and Marshall Islands from January through July 1944, including a bombardment of Kusaie Island on June 1. She then escorted support shipping to the Marianas from August through October. Following further patrol and escort duties in the Gilbert and Marshall Islands from November through March 1945, she guarded a logistics support group, supplying fast carrier fast forces in the western Pacific, from April into June. Sailing via Pearl Harbor, she arrived at San Francisco on July 15 for overhaul.

Remaining on the United States west coast, she was decommissioned on December 19, 1945. Struck form the Navy list on January 8, 1946, she was delivered, on May 8, 1947 to the National Metal and Steel Corp., Terminal Island, Calif. and scrapped in 1948.

The U.S.S. Sanders received four battle stars for World War II service.

There was a Sanders on the Arizona who survived Pearl Harbor. His name is Elmer L. Sanders and he was from Oklahoma. He was a Gunners Mate 1st Class. No other information is known about him.

were ordered to construct a road from Beaver Dam Creek to Rocky Creek. Beaver Dam Creek is now under Lake Badin and Rocky Creek is in Anson County. In 1775 Moses was a Justice of the Peace in Montgomery and Aaron was appointed as a Constable in Moses' room and Aaron, Moses and George Sanders were holders of land grants on Barnes Creek. George's grant has not been viewed but Aaron and Moses received their grants on Barnes and Abner Creeks, respectively, in 1773. Their properties were surveyed on the same day, June 27, 1773. His wife, referred to as the "widow Sanders" in subsequent land documents, remained with her family on Aaron's grant land on Barnes Creek. Nimrod Sanders remained with his mother, living in the house on Barnes Creek. William Aaron's family: wife Joan (Joanah) Bailey Sanders; sons: Stephen, Luke, Nimrod and possibly Jacob, Jesse and Benjamin. I realize we haven't considered any family of Isaac.

Joanah Sanders

On November 29th 1803 grant #1923 was issued to Joanah Sanders. It was for 50 acres described as "Beginning at a Hickory on Barnes Creek." The survey was adjacent to Jacob Sanders and Stephen Sanders. Luke and Nimrod Sanders, her sons, were the chain carriers. Entered August 20, 1803. Entry 5760. Bk. 110. Pg. 416. Card #1449. At first glance we assumed we had found a new Sanders. However, after reading the warrant for the survey, closely, we discovered "Joanah" is noted as a her. The warrant also stated the survey was to include her improvement. This would indicate that this property would be a part of the original grant to Aaron in 1773 as her home was located there. She lived there with Nimrod, her youngest son, until her death. Her sons Luke, Nimrod, Stephen and possibly Jacob, if he were a son, lived contiguous to her.

Nimrod Sanders 1794

He is possibly the youngest son of William Aaron. We realize that Aaron's wife was Joanah Bailey Sanders. Joanah remained on her husband's (Aaron) land grant after his death in 1781. Her youngest son, Nimrod, stayed on the grant land also and he was enumerated there in the 1800 census of Montgomery

County. Nimrod Sanders is the only male in the house. He is listed as aged between 16 and 25. The only female listed is aged over 45, born before 1755. I submit that this is Joanah or the "widow Sanders."

They are living on the property on the Reedy Fork of Barnes Creek. In 1810 Nimrod's family has grown. He has a wife and 2 sons under 10 and 2 daughters also under 10. His mother is still with him and she is shown as being born before 1765. In 1836 Nimrod sold the grant land to William Strider. Jacob Sanders grant land was adjacent to Aaron's or Joanah's or Nimrod's property, depending on the actual date one views the chain of title, as they all, at different times, were listed as owners of the same property. Nimrod received a parcel of 100 acres on January 5th 1806. The grant number 2001 was for land on the waters of Barnes Creek. Issued 14 November 1804. Entry 5784. Book 116 Pg. 436. Card 1672. This transaction has not been reviewed. Nimrod is a second generation Sanders.

Jacob Sanders

Jacob is first noted as a reference in 1794 in a grant to John Crump. His property is noted along three courses of Crump's land and then ties into "Aron" Sanders' old corner. This was an important discovery as the tie into Aron's corner is the same corner "tie-in" that is referenced in a grant to Elias Butler in 1785. In the 1785 Butler grant, the "Widow Sanders" line is noted and is the same bearing and distance on Barnes Creek as in Crump's grant. This is more evidence to corroborate our belief that "Aaron" and "William Aaron" are the same person. Jacob was a neighbor to the west of Nimrod and his mother, Joanah. Jacob Sander's property was surveyed for him 7 January 1800. Grant 1894. It was for 100 acres on the "waters of Barnes Creek." Issued 20 August 1803. Book 110 Pg. 406. Card 1420. Evidently he was already living on the property prior to the issuance of the grant. Jacob was also noted as a chain carrier with James Neal for Neal's survey in 1798. It was for 300 acres near William Hamilton's corner on the north side of Barnes Creek. (William Hamilton was Moses Sander's brotherin-law and a neighbor of Moses.) Jacob Sanders is listed in the 1790 census as being born before 1784; four boys in the

family born after 1784; three females. In 1800 his family is listed as Jacob and wife born between 1756/1774; 4 boys born between 1785/1790; 2 boys between 1790/1800; 4 daughters. We could date Jacob's birth as between 1767 and 1773. Probably, and because of proximity to Joanah, he may be William Aaron's oldest son. Jacob is a second generation Sanders.

Stephen Sanders

We have reviewed 4 land grants, which show Stephen Sanders was living on or near Barnes Creek as early as 1785. He was probably a son of Aaron and Joanah Sanders. Stephen and "Aron" Sanders (Aron was Moses Sanders son) were chain carriers for the 1785 survey for Elias Butler. The surveyor noted "the 'Widow Sanders' line" on the south side of Barnes Creek. The date 1785 leads us to believe that "Aron" is the 16-year-old son of Moses. Stephen is a young son of the deceased Aaron. They were cousins. Stephen Sanders is referenced in another grant to Francis Jordon on 15 April 1785, as a chain carrier and the other carrier is Moses Sanders. We noted that the survey for Jordon's land was one week after the survey of Elias Butler. Butler's land and Jordon's land are both contiguous to Joanah's property. This is more reason for Moses and his son Aron to make the trip south to ensure the Sanders families interests were upheld. Butler's survey was adjacent to what is described as "Aaron's old line." It appears that Jordon's survey may have been a portion of Aaron's original grant. In 1794 Stephen Sanders' 4th corner is referenced as a starting point for a survey for John Gray Blount. Stephen's corner is about 2.5 miles above Densons Fork and on a fork of Barnes Creek. The Randolph County line is due north of this corner, along John Blount's line, about 1.5 miles. Three-quarters of a mile east of the intersection of the county line and Blount's intersection, is the beginning corner of Benjamin Sanders' property. The beginning corner of Stephen's survey in 1794 is a point on the Widow Sanders Line on Barnes Creek. On 30 December 1801 Stephen entered a grant, 1972, for 50 acres on the waters of Barnes. Issued 19 December 1803. Book 117 Pg. 222. Card 1642. He is a second generation Sanders.

Benjamin Sanders

Benjamin received one of his several warrants, and probably the first grant, in February 1793. This property is about a

mile and a half north of Stephen Sanders' land, (which is next to Joanah), and lies on the Montgomery/ Randolph County line. It is described as on both sides of Barnes Creek. Were Stephen and Benjamin brothers, sons of Aaron or perhaps cousins? He acquired more land around his Barnes Creek/ Randolph line in the late 1790s and early 1800s and in 1833 sold it all, 300 acres, to John Lucas. Benjamin also had property on Williams Creek, which is about 6 or 8 miles southeast of the Barnes Creek families' location. He sold this piece in 1785 to Steven Miller. Benjamin is a second generation Sanders.

Luke Sanders

In October 1799 Luke Sanders received a warrant for 50 acres on Barnes Creek. It was surveyed September 26th 1799. Grant 1767 was on "both sides of the Reedy Fork of Barnes Creek." Entry 5133. Issued 23 November 1801, Book 111 Pg. 276. Card 1469. Luke received another entry in January 1802, number 2083 for 50 acres. Entry 5783. Card 1755. Issued 27 June 1806. Book 122 Page 42. We have not viewed this record. Luke's 1799 survey is south of and adjacent to Joanah and Nimrod's land. The chain carriers for Luke's survey were himself and Nimrod Sanders. Luke is a second generation Sanders

George Sanders 1773

George was issued a grant in May of 1773 on Duncombs Creek. Both Moses Sanders' and George Sanders' properties are referenced as being adjacent to Nathaniel Steed. In a warrant to Joseph Carnes dated 1790 and noted as being taken from an earlier warrant dated 178? to George Kirk, it is noted that Carnes is to have 200 acres on Duncombs Creek below George Sanders running towards the county line (north), joining Sanders' line and Steed's line. This again puts George in the proximity of Moses. He was ordered to help build the road from Beaverdam Creek to Rocky Creek as was Moses, Aaron and others in 1774.

George may have had 3 sons—James, Joshua and Rueben. George may be a first generation Sanders.

Rueben Sanders

Rueben Sanders was issued a grant entered as #184, grant #242 issued 11 October 1783. It was for 100 Acres of

land on "Duncuns" Creek. His grant uses George Sanders' line as a neighboring reference point. George Sanders' grant was dated 1773. Rueben's was 1783. He is very likely a son. The chain carriers for Rueben's grant were: James Sanders and Joshua Sanders. Perhaps these two men were either Reuben's brothers or his sons. Or possibly they were sons of another first generation Sanders. Two different Joshua Sanders are listed in the 1790 census of Montgomery. Two different James Sanders are listed in the census of 1790. Rueben would be a second generation Sanders.

Joshua Sanders

We haven't much on Joshua. Two Joshuas are listed in the 1790 census of Montgomery.

He is listed as a chain carrier for Rueben's grant surveyed in 1782.

He is a second generation Sanders

James Sanders

Benjamin Randle received a grant on 1 July 1790. The property was on Barnes Creek and James Sanders' property was referenced as a starting point in the description of the grant. We would expect this James to be the "chain carrier James" noted on Rueben's survey. Two James Sanders are listed in the 1790 census of Montgomery. One of them is our subject and shows, I believe, an extended family—three men over 16 years of age; two boys under 16 and two females. The other James lists one male over 16 with four boys under sixteen and two females. In the 1800 census one of the James is not listed. We believe that the "extended" family, James, is still in Montgomery with four sons born between 1785/90, one son born 1790/1800 and a wife. The 1800 census shows James being born between 1756 and 1774. He may be a second generation Sanders. The other James is listed in District 2 of the Montgomery county tax list of 1787. This is the same district as Jeffery Sanders. This district, we believe, is on the Rocky Fork of Little River. This would tie Jeffery and James into the William Sanders family. Preliminary research on this family shows them migrating to South Carolina. We don't have any family tie into them. However, one might consider this: Elias Butler, who owned several pieces of property in Montgomery

County, used "Jefery Sanders" as a chain carrier on a survey for a grant on the Rocky Creek in 1785. Elias Butler had several pieces of property in the Barnes Creek area as well.

Jesse Sanders

The first reference to Jesse is as a chain carrier for a survey for Little Berry Hicks on Spencer Creek 18 February 1787. Spencer Creek runs north and south parallel and south of Barnes Creek. It flows in the Uwharrie just south of the mouth of Barnes Creek.

We would estimate the location of Butler's survey to be 4 or 5 miles south of the Sanders family's holding. Jesse may be a second generation Sanders.

The William Sanders Family Group

William, Nathaniel and James Sanders are shown on various deeds to be from the Cheraws District, Craven County, South Carolina. These deeds date from 1757 through 1784. (Family History Library (LDS) films #0018271 and #0018145.) William Sanders first acquired property in Anson in 1757 on the Woody Branch of Rocky Creek. He is listed as being from the Camden, South Carolina, district in 1784. Nathaniel acquired a grant in 1766 on Buffalo Creek near Little River. They were very active in Anson and Bladen Counties, notably on the Waccamaw, Gum Swamp, Shoeheel in Anson prior to 1784. William Sanders is shown on many records as receiving several pieces of land on the Rocky River, in Montgomery County in the 1780s.

Elias Butler used Jeffery Sanders as a chain carrier on his survey for his property on Rocky Creek in 1785. We believe that Jeffery was a member of the William Sanders family group. There is a possible connection of this group to the Barnes Creek Sanders through Elias Butler. In 1779 Elias entered a warrant for a grant on Barnes Creek upon which Daniel Sanders had an improvement. (Daniel Sanders is discussed earlier in this work). Elias also had a piece of property adjacent to Jacob, Luke and Joanah Sanders on Barnes Creek. When Elias surveyed that particular piece of property in 1785, he used Aron and Stephen Sanders as chainers. The conclusions, regarding the relationships, are evasive and the writer will leave the opportunity for discovery to the reader.

This family group may well start with John Sanders in South Carolina. He had

two sons, George and Thomas. "George was the father of Nathaniel Saunders, who became a man of some means." (*A History of Marion County, South Carolina, 1902*, page 142, by W. W. Sellers, Esq. Montgomery Co., N.C., Extant Deeds 1774-1842)

The Patrick Sanders Family Group

Patrick Sanders received his first deed in Anson County in 1758, for property on Mountain Creek. He also had property on Buffalo Creek in 1769. In a deed to James Bolton, in 1779, Patrick names his wife as Mary. James Sanders received his first deed in 1761 for property on Mountain Creek. It was adjacent to Patrick. Their properties, we believe, are located just south of the Montgomery County in Richmond County formed in 1779. Patrick Sanders last land transaction in Anson County was in 1779. We find him on the 1782 tax list of Rutherford Co., N.C. The next entry we find for Patrick is in Spartanburg, S.C. 1800. In the 1800 census he is listed living next door to his sons William and Patrick Jr. He died between 1800 and 1810, we believe in Spartanburg. Patrick and James Sanders was signatory to "The Regulators Petition" of Anson County in 1769, as were other Sanders from Anson County. They were protesting for relief of unfair taxation, without representation. Two other Sanders men are listed from Anson on the roster of men who served in the Battle of Adamance, which was the breakup of the Regulators, David and Thomas E. We do not find any other records of these 2 men in our search of the records of Montgomery and Anson. At this time we wonder why we do not find any of the Barnes Creek Sanders signatory to the Regulators list. Perhaps they were not yet living in North Carolina.

Summary

We will acknowledge that there are gaps in our research and welcome all documented evidence that might open new avenues for us to travel in our quest to find our ancestors. The Internet has made available volumes of information that might have taken years for our predecessors to ferret out. As much of a help as it has been, it is also a hindrance. When well meaning searchers cut and paste a GEDCOM to their family group sheet without checking original source material and the next searcher quotes that GEDCOM as a reliable source. Much unverified information is soon recognized as fact. And so on and so on...

Revolutionary War Pension File Yields Much Information For "Unknown" Obed Sanders

The following was sent in by Dorothy Hughes, P.O. Box 3799, Sunriver, OR 97707, <gordhughes @aol.com>

I found my husband's third great grandfather, David Sanders in the 1840 census living in Lawrence, St. Lawrence County, New York. In a nearby household was an Elizabeth Sanders, age 78, who was receiving a revolutionary war pension. I looked up her name in the Index to Revolutionary War Pensions, National Archive's film number M 312, Roll 1, A - S. and found Elizabeth listed with Obed Sanders, N.H., Vt. David Sanders always listed Vermont as his place of birth in the census.

I ordered the Family History films 0972116 (Augustus - Mary Sanders-Saunders) and 0972117 (Nathaniel -Zachariah Sanders-Saunders). I found Obed and Elizabeth on the 0972117 film. We are quite sure he is my husband's fourth great grandfather! (Unknown to us before!) Obed lived in Bradford, Vt. but he enlisted for one year with his two brothers Jonathan and John at Haverhill, New Hampshire in the New Hampshire line in December 1775 and entered service February 1776 as privates in Captain Samuel Young's Company in Colonel Timothy Bedel's Regiment. They marched to Quebec and were involved in the Siege of Quebec and then the retreat back to Ticonderoga.

As a result of marching on snowshoes on snow and ice, Obed had to walk with crutches his last 25 years. He received his pension in 1818. At that time he was living in Dickinson, Franklin Co., New York. He died in 1826.

His widow, Elizabeth, received a widow's pension in 1839. She was his second wife. Obed and his first wife, Meribab Stone, had eight children, including David. Obed and Elizabeth had two daughters.

On the first application Obed filed he gave the wrong commander for his Regiment . He had to have his two brothers file affidavits to confirm his service. When Elizabeth filed her application she had no marriage certificate so she had to file affidavits proving her marriage, which gave us the name of a younger brother, Green Sanders. Because of all their problems we got lots of information. There were nearly a hundred pages in their file including a page torn out of

the family bible with all the names and the birth dates of the children. Most files only have ten or twenty pages.

If you think you may have an ancestor who fought in the Revolutionary War look them up in the Revolutionary War Pension Index.

When I was putting my films away at the Family History Center I noticed someone else's film — Colonial Gravestone Inscriptions in the state of New Hampshire (FH Film # 0823810). I found one Sanders on the whole film -Jonathan Sanders died January 1, 1774 in his 60th year, buried in the Haverhill Cemetery. Could this be the father of Jonathan, John, Obed and Green? I also found Colonel Timothy Bedel 1740 - 1787 in the same cemetery.

I put Jonathan Sanders' name in Family Search and came up with a Jonathan Sanders born in Haverhill, Massachusetts in 1712. His father was Avery Sanders and his mother was Abigail Green. (One of Obed's brothers was named Green.) I ran the pedigree for Jonathan Sanders and it went all the way back to 1420 England! Could all these people be ancestors of my husband?

Martin Sanders (between 1815 - 1823 Georgia), who was married to Anna Sanders (b. abt. 1832 Miss. - not known if related to Martin) on 16 July 1846 in Monroe Co., Miss. The article further states that the author located the Benjamin Sanders' family in the census records of Monroe Co., Miss. in 1850 and 1860 but the only entries in those two census years that "fit" are for a head of household named William Saunders, as follows:

Alvin Saunders Was First Governor of Nebraska

This material on Alvin Saunders was submitted by Susan Saunders, 4462 E. 1251 Rd. Trlr. 9, Eadville, IL 605 18, <susansaunders@msn.com>. For more detail on Alvin Saunders, see page I of the April 1998 issue of *Sanders Siftings*.

Alvin Saunders born July 12, 1817 in Fleming County, Ky. to Gunnell and Mary [Mauzy] Saunders. Sometime after 1829, Gunnell and Mary Saunders and their sons moved to Sangamon County, Illinois, where their oldest son Jonathon Robinson Saunders and his family had settled. At this time the family met Abraham Lincoln. Sometime later Gunnell and Mary followed their sons Presley and Alvin to Iowa (part of the Wisconsin Territory) where Presley Saunders laid out the town of Mt. Pleasant, Iowa

This was where Alvin Saunders learned the trade of store keeper and was postmaster in for seven years. He also tried his had at banking for a while. He had a common school education. He pursued law but never practiced law.

Alvin was elected as a member of the Iowa State Constitutional Convention in 1846. He was a member of the Iowa State Senate 1854-56 and 1858-60. He was appointed Governor of the Territory of Nebraska from 1861-1867 by Abraham Lincoln. The renewal of his appointment was signed by Mr. Lincoln on the night he went to Ford Theater and this was the last official paper signed by the President. Alvin also served as a U.S. Republican Senator from Nebraska from 1877-1883. He was appointed by Congress to be one of the Commissioners to organize the Pacific Railroad Co.

He and his wife Marthena Barlow had two children Charles and Mary Angeline. Governor Saunder's daughter Mary "May," married President Benjamin Harrison's son Russell.

Alvin Saunders died in Omaha, Neb. 1 Nov 1899 and is interned at Forest Lawn Cemetery.
