# AARON BENJAMIN SANDERS

**BORN:** July 24, 1837                      Corinth, (Alcorn County) Mississippi

He enlisted in Confederate Army, October 15, 1862 at Columbus, Mississippi as a Private in Company E, 5th Regiment, Mississippi State Troops Infantry. He was captured at Vicksburg on July 4, 1863 and paroled 6 days later. He was discharged in Marshall, Texas on August 9, 1865.


